Cautus Asset Management ("CAM," "we," "us," or "our") respects your privacy and is committed to protecting it through this Privacy Policy. This policy describes the types of information we may collect from you or that you may provide when you visit the website <https://cautusassetmanagement.com> (our "Website") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- Through your interaction with our landing pages, waitlist forms, and informational content.

It does not apply to information collected by any third party, including our sub-domain for the investment platform (<app.yourdomain.com>), which will have its own terms and policies.

Please read this policy carefully to understand our policies and practices regarding your information. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using this Website, you agree to this privacy policy.

Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including information:

- By which you may be personally identified, such as name, postal address, email address, and telephone number ("personal information");
- That is about you but individually does not identify you; and/or

- About your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- **Directly from you when you provide it to us.**
- **Automatically as you navigate through the site.** Information collected automatically may include usage details, IP addresses, and information collected through cookies and other tracking technologies.
- **From third parties**, for example, our business partners.

Information You Provide to Us

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. This includes information provided at the time of joining our waitlist, requesting information, or subscribing to our newsletter.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes.

Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The technologies we use for this automatic data collection may include cookies (or browser cookies). You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website.

- For any other purpose with your consent.

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business (e.g., website analytics, email marketing platforms).
- To fulfill the purpose for which you provide it. For example, if you join the waitlist for the CAM investment platform, we will use that information to manage your application and provide you with updates.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

Your Choices About Our Collection and Use of Your Information

We do not control third parties' collection or use of your information to serve interest-based advertising. However, these third parties may provide you with ways to choose not to have your information collected or used in this way.

We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration, and disclosure. All information you provide to us is stored on our secure servers behind firewalls.
